Forklift Truck Training



We provide courses for operators to be trained in the safe use of Forklift Trucks. The course is provided by an accredited instructor and meets the requirements of the HSE's L117 approved code of practice for Lift Truck.

Operators will be given an understanding of what can cause instability, best practice driving techniques, battery maintenance or other fuel relevant training applicable to the truck. The course also teaches operators how to stack and de-stack into racking and unload from vehicles if applicable.

Pedestrian Truck Training

We provide courses for operators to be trained in the safe use of Pedestrian Trucks covering a range of aspects. The course is provided by an accredited instructor and meets the requirements of the HSE's L117 approved code of practice for Lift Truck.

Operators will be with a full overview of the truck and its functionality, best practice driving techniques, battery maintenance. The course also teaches operators about stability and the causes of common accidents.

VNA and Order Picker Training

We provide courses for operators to be trained in the safe use of Order Picker and VNA trucks covering a range of aspects. The course is provided by an accredited instructor and meets the requirements of the HSE's L117 approved code of practice for Lift Truck.

Operators will be given an understanding of what can cause instability, best practice driving techniques, battery maintenance or other fuel relevant training applicable to the truck.

Course can be provided on a 1-1 basis or for a group of up to 3 operators. Conversion courses are also available.

Rope Escape Training - with use of a VNA/Order Picker

All trucks that lift personnel above 3m should be fitted with a means of escape, in the event an operator is stranded at height.

Employers should have a 'Rescue plan' in the event of this happening and cannot rely just on a truck having a manual lowering valve.

Emergency Escape/Egress training requires refreshers annually as per HSE OC 282/31 - It is recommended that refresher training should be carried out least every 12 months to produce an effective 'conditioning' and maintain confidence.

Jungheinrich provide training to keep your operators compliant with the law.
